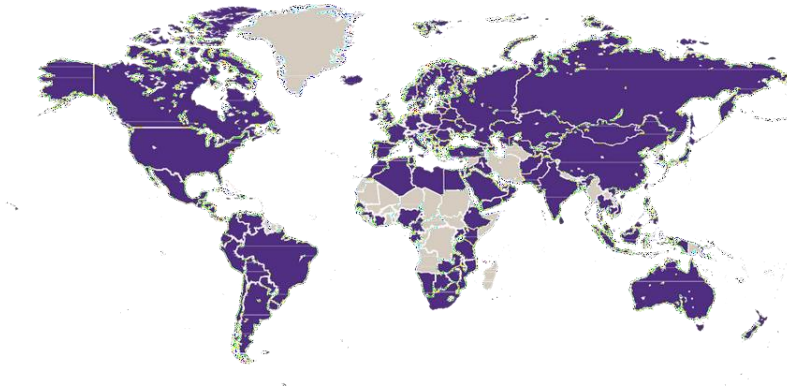

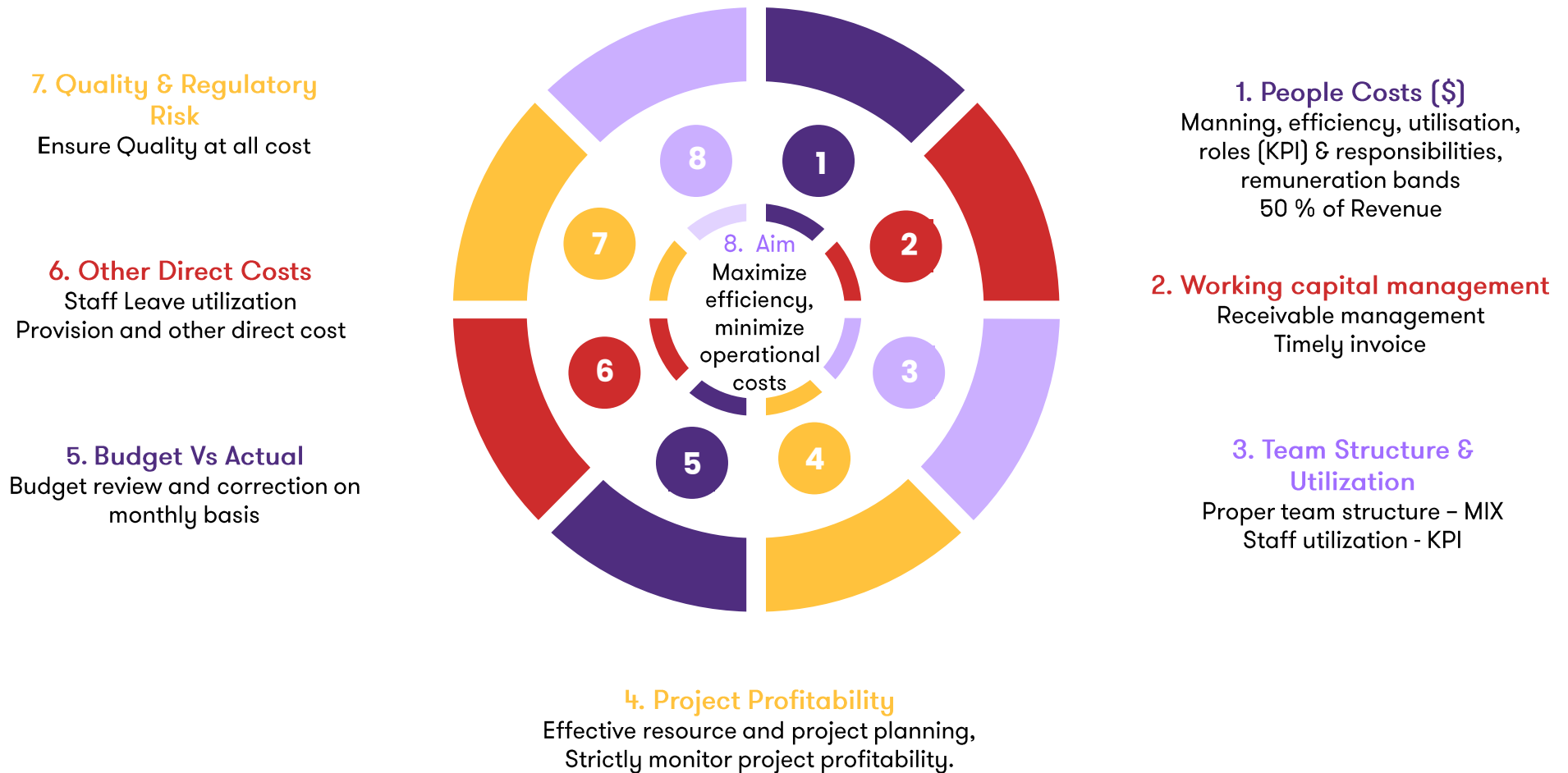

Key market trends: Local & Global Challenges and Opportunities

In Bahrain and the broader Middle East, key market trends include increasing **digital transformation** efforts to enhance efficiency and service delivery, with over 70% of firms in the region investing in **digital technologies**. Additionally, evolving **regulatory frameworks** require specialized expertise in **tax and compliance**, with a reported 40% increase in **regulatory updates** annually.

Globally, firms must navigate **rapid technological advancements**, manage **compliance** across varying jurisdictions, compete for top talent, and address growing **cybersecurity threats**, with global cybercrime costs expected to reach \$10.5 trillion annually by 2025.
